**The Environment Agency** is now focusing on all premises due to the growing number of oil pollution incidents they are called to attend. Many of these alarming occurrences can be attributed to separators not being serviced properly and have resulted in water courses being polluted and site owners being prosecuted.

It is important to understand that separators require regular maintenance in order to prevent pollution. The EA PPG3 and European Standard EN858-2 stipulates that they are serviced at least twice a year and in accordance to the manufacturer's instructions and guarantees.

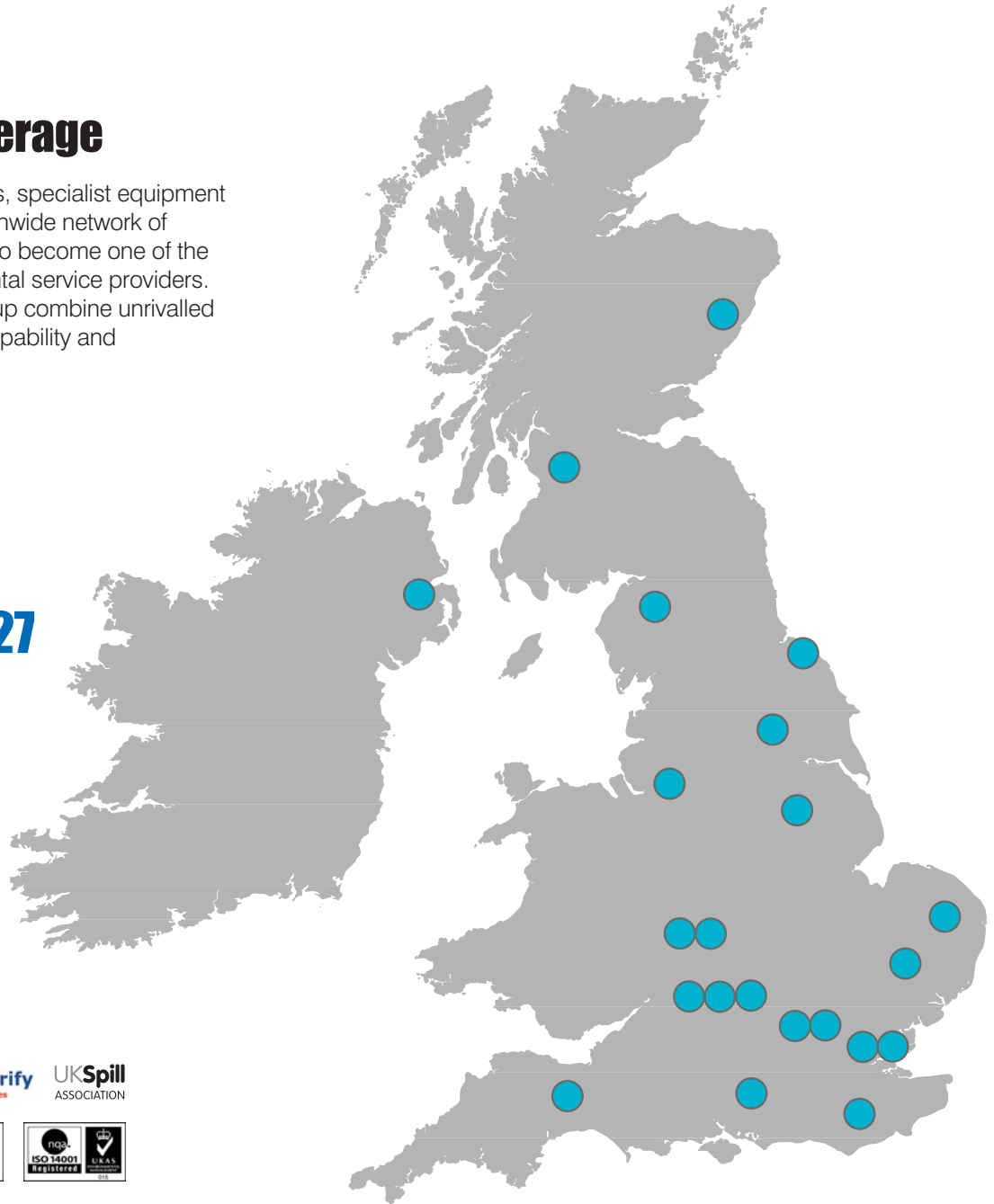
### Tanks Structural Survey
